The “Valley of Gems” show will be held on **June 5-7, 2009**. This is a Friday, Saturday and Sunday show. It will run from Noon to 6 PM Friday, 10 AM to 5 PM Saturday and 11 AM to 4 PM Sunday. We will be using the Fruitland Grange building and grounds. The grange hall is located at the corner of 112<sup>th</sup> and 86<sup>th</sup> in Puyallup.

**Directions:** Take I-5 to exit 127 (highway 512), East to Canyon Ave. Right (South) to the first traffic light (112<sup>th</sup>), left on 112<sup>th</sup> to the second traffic light, which is 86<sup>th</sup>, left on 86<sup>th</sup> for about 300 feet. The ground level entrance is located on the Northeast side of the building through the double doors. An alternate route is Highway 167 South from Renton to Highway 512 up to the top of the hill and exit to Highway 161 (Meridian). The street bordering the South side of South Hill Mall is 112<sup>th</sup>. Turn right on 112<sup>th</sup> to 86<sup>th</sup> (past Costco), and then right on 86<sup>th</sup> and the grange hall will be to your left.

**Setup:** is from **12:00 PM to 6:00 PM** on Thursday. The club will host dinner at 6:30 PM on Thursday.

**Indoor Dealer** space is **\$8.00** per foot of frontage space. You will have some side space available, and a minimum of 3’6” between dealers if your space is along the wall.

**Outdoor Dealer** space is **\$5.00** per foot of frontage space.

**Tables:** If possible, please furnish your own tables. We have approximately 50 tables available for a fee of **\$5.00** each. Each dealer must provide his or her own signage and lighting. The host club will provide power for your booth for indoor vendors only.

Parking for Dealers and Club members will be provided on the West end of the grange, this area is also available for those who wish to camp on the grange grounds. As host club we will provide some daytime security but assume no liability for damages due to fire, theft, or vandalism. The grange will be locked at night but no additional security is available from the host club.

Due to space limitations the maximum booth footage available inside the hall is **21 feet**. If there is a cancellation and more space opens up you may be offered extra footage.

Dealers agree to the following:

1. Return the signed copy of this contract with deposit.
2. Dealers are encouraged to provide a case display to help enhance the show and rock hounding in general. If you wish to use a club case please notify the Dealer Chairperson in advance. It would be appreciated if an item of interest could be donated for the show raffle along with your business card to be displayed in the raffle prize case throughout the show.
3. Dealers cannot take down or remove their materials prior to show closing on Sunday unless prior arrangements have been made with the show chairman.

A duly authorized member of Puyallup Valley Gem & Mineral Club Show Committee signs both copies of this contract and then this becomes a valid and binding contract when signed by the dealer. Please make checks payable to PVG&MC.
